

DIONYSUS WINE CLUB - TERMS AND CONDITIONS

To join the Dionysus Wine Club you must be 18 years of age or over, be a resident of and residing in Australia, and agree to the terms and conditions as set out below. There is no membership fee payable for joining the Dionysus Wine Club. Dionysus Winery reserves the right to grant or refuse membership of the Dionysus Wine Club to any applicant. By joining and providing your details to the Dionysus Wine Club, you authorise Dionysus Winery (ABN 36 583 780 692) to debit the provided credit card with the total cost of the wine deliveries as they occur annually in your chosen delivery months. Deliveries will be processed automatically, with a minimum 7-days notice, by email prior to being debited.

Joining the Dionysus Wine Club entitles you to receive your membership discount on wine purchases, both online and at the cellar door. Membership also entitles you to receive special and exclusive wine offers throughout the year. Members will be notified prior to each shipment of wine and have a choice of whether they receive red, white or mixed half dozens.

Your wine club discount cannot be used with any other offers. Shipments are for members personal consumption only and must not be used for retail sale.

TERMINATION OF MEMBERSHIP: Dionysus Wine Club memberships are ongoing, however, members may terminate their membership at any time after 12 months or a minimum of 2 six pack deliveries of wines purchased, by notifying Dionysus Winery by phone, email admin@dionysus-winery.com.au or by visiting the cellar door in person. If the member wishes to cancel their membership, the request must be received prior to the processing and despatch date of their notified upcoming delivery. Members are liable to pay for only those wine packs that have been dispatched prior to membership change/cancellation notification.

CHANGE OF DETAILS: The member understands that it is their responsibility to inform Dionysus Winery of any change in address and delivery details via the Dionysus Winery website or email to admin@dionysus-winery.co.au. Charges incurred with recovery of wines to an old or incorrect address will be the responsibility of the member.

DELIVERY: Dionysus Winery uses Australia Post to deliver physical goods. Delivery may take between 2 and 14 days, depending on the location and delivery method. Wine club orders requiring delivery must be in multiples of six bottles (excludes promotion and special offers where stated).

We can deliver within Australia only. Deliveries cannot be made on weekends or public holidays. If you are unsure whether we can deliver to the area you live in, please contact us. Please note that all Australia Post deliveries to rural areas will be left at the local Post Office. Occasionally our couriers may leave your purchases at the local Post Office or local distribution depot as they have been unable to deliver to your specified delivery address. In this instance a calling card will be left for you, advising the location of your purchases for collection. If the item(s) have not been collected within 14 days of leaving a calling card, Dionysus Winery will be contacted to clarify further action.

The goods will not be delivered to persons under the age of eighteen (18) years. We may request that the person who receives the goods provide satisfactory evidence of proof of age. We will refuse to deliver the goods if a person receiving the goods is unable or unwilling to provide evidence of proof of age. Anyone at the nominated delivery address who receives the goods is presumed to be authorised to receive the goods.

If we are advised that the carrier is unable to deliver the goods, or if the delivery address has not been updated prior to your wine selection despatch, we will then attempt to contact you to arrange re-delivery. Return & re-delivery fees apply.

PRICE & CREDIT CARD CHARGES: All prices are quoted in Australian Dollars (AU\$) and include GST. Our prices are subject to change – the price payable for the goods is the price applicable on the date when we confirm your order. Orders are by credit card only. We accept Visa or MasterCard.

As a wine club member, you understand your wine club selections will be processed and shipped automatically in your nominated delivery times. Notification of your upcoming wine delivery will be made by email with a minimum 7 days' notice prior to processing payment.

LIQUOR ACT : Under Australian law, you must be 18 years or older, to order or receive alcoholic beverages from Dionysus Winery. It is an offence to sell, supply or obtain liquor on behalf of a person under the age of 18. NSW Liquor Licence number LIQW824011909. Dionysus Winery encourages a responsible attitude to the consumption of alcohol.

OTHER: Dionysus Winery reserves the right, at its sole discretion, to vary the terms and conditions of the Dionysus Wine Club. Should Dionysus Winery vary the terms and conditions, we will notify the Member via the email address provided on the Member's application form. Your continued participation in the Dionysus Wine Club after such notification will constitute your deemed acceptance of such variations.

Dionysus Wine Club reserves the right to request verification of age, identity, residential address of Members and any other information relevant to Membership or participation in the Dionysus Wine Club. Verification is at the discretion of the Dionysus Wine Club, whose decision is final.
